Discussion on possibility of cashing in a CD and put it in a Sewer Reserve Fund. Leighow's requested to hook on to town water. Rob getting a proposal for service agreement from Pall. Bev to review White Pines agreement to see if they have a responsibility for maintenance costs.

**Motion:** Loan \$5000 to the pool board from the renovation fund to be paid back by 12/01/2014.

Personnel - Discussion on Substitute Crossing Guide – proposing to hire Debra Carey as substitute crossing guide. Discussion held on background check for all borough employees.

Motion by Marvin Fisk, 2<sup>nd</sup> by Jen Rine, motion carried.

**Motion:** Hire Debra Carey as substitute crossing guard as long as background checks come back favorable.

Motion by Charlie Hartzel, no 2<sup>nd</sup> motion dies. Will be discussed at a later date
